INTEREST RATES and INTEREST CHARGES:	
Annual Percentage Rate (APR) for Purchases & Cash Advances	12.99 % to 17.50 % depending on your credit history. This APR will vary with the market based on the Prime Rate.
APR for Balance Transfers	0.00% Introductory APR for 6 billing cycles from date of account opening. After that, your Standard APR will be 12.99% to 17.50% depending on your credit history. This APR will vary with the market based on the Prime Rate.
Penalty APR and When it Applies	None
Paying Interest	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$1.00.
